Investment returns shown in the table above were calculated by Callan LLC, the Board's investment consultant, by computing the percentage change in the trust unit value of each Investment Option. The unit values were provided to Callan for computing the investment returns. The investment periods covered for the Investment options are from December 1, 2002 through September 30, 2018. Initial funding for the Plan began in December 2002.
