published by @MyFloridaPrepaid and the corresponding weekly partner account on the designated post date for that week:

- a. Follow both @MyFloridaPrepaid and the weekly partner's Instagram account;
- b. Like the Collab Post; and
- c. Tag at least one (1) friend in the comments of the Collab Post.

Each eligible comment tagging a friend constitutes one (1) entry.
