Any one of these documents can be used for proof of Florida residency for the past 12 consecutive months.

Florida Driver's License (FDL)	<ul style="list-style-type: none"> <li>▪ Must have been issued at least one (1) year from application date</li> <li>▪ Acceptable if expired for less than one year</li> </ul>	<ul style="list-style-type: none"> <li>▪ FDL expired for more than one (1) year</li> <li>▪ FDL issued less than one (1) year from application date.</li> </ul>
Florida Vehicle/Vessel Registration (FVR)	<ul style="list-style-type: none"> <li>▪ Must have been issued at least one (1) year from application date.</li> <li>▪ If more than one year (1) old, acceptable if the parent/legal guardian's address is in Florida</li> </ul>	<ul style="list-style-type: none"> <li>▪ FVR issued less than one (1) year from application date.</li> </ul>
Florida Voter's Registration Card	<ul style="list-style-type: none"> <li>▪ Registration or issue dates are at least one (1) year from application date.</li> <li>▪ Cards issued more than five (5) years ago are acceptable if the parent/legal guardian's address is in Florida</li> </ul>	<ul style="list-style-type: none"> <li>▪ Issued less than one (1) year from application date.</li> </ul>
Florida Homestead Exemption (FHE)	<ul style="list-style-type: none"> <li>▪ Homestead exemption acceptable if dated 2020 or earlier</li> <li>▪ 2021 exemptions are acceptable if the word "RENEWAL" appears on them</li> </ul>	<ul style="list-style-type: none"> <li>▪ FHE dated 2021 are not acceptable without the word "RENEWAL"</li> <li>▪ FHE Applications are not acceptable</li> </ul>
Florida Full-time Employment Documents	<ul style="list-style-type: none"> <li>▪ Copies of most current pay stub and one at least one (1) year from application date.</li> <li>▪ Copies of W-2 Wage &amp; Tax Statement from 2020</li> <li>▪ Signed letter from employer on company letterhead</li> <li>▪ W-2 Wage &amp; Tax Statements for 2021 are acceptable only if received with additional documentation that the parent/legal guardian was employed at least one (1) year from application date.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Not employed in Florida for at least one (1) year</li> <li>▪ 1040 Tax returns are not acceptable</li> </ul>
Military Orders and/or Leave and Earnings Statement	<ul style="list-style-type: none"> <li>▪ Military Orders reflect Florida as Home of Record</li> <li>▪ Leave &amp; Earnings Statement reflects Florida in "State Tax" section</li> <li>▪ <u>There are no date requirements for Military Orders</u></li> <li>▪ APO addresses w/valid Florida residency docs</li> </ul>	<ul style="list-style-type: none"> <li>▪ Out of State address without APO designation and with valid Florida documentation are not acceptable without Military Order or Leave &amp; Earnings Statement</li> </ul>
Florida Report Cards and/or Transcript	<ul style="list-style-type: none"> <li>▪ Must be from 2020-2021 school year and reflect beneficiary's name. School must be in Florida</li> <li>▪ If report card and/or transcript was issued prior to 2020-2021, the parent/legal guardian and/or beneficiary address must be in Florida</li> <li>▪ All grading periods do not have to be completed</li> <li>▪ The same rules apply to progress report from a preschool or a daycare</li> </ul>	<ul style="list-style-type: none"> <li>▪ Report card is from 2021-2022 school year</li> <li>▪ Report card is not from Florida or location of school is unknown</li> <li>▪ Report card is not legible</li> </ul>
Florida Birth Certificate	<ul style="list-style-type: none"> <li>▪ Acceptable only if the child was born one (1) year or less <b>prior to receipt of application</b></li> <li>▪ Must show Florida as State of Birth</li> <li>▪ Birth registration cards are acceptable</li> </ul>	<ul style="list-style-type: none"> <li>▪ Beneficiary is over one (1) year old</li> <li>▪ Birth Certificate was not issued in Florida</li> </ul>
Miscellaneous Documents	<ul style="list-style-type: none"> <li>▪ FL lease agreement and began at least one (1) year prior to application date.</li> <li>▪ FL Declaration of domicile issued at least one (1) year from application date.</li> <li>▪ Copies of utility bills or bank statements, w/ FL address, indicating 12 months of residency at least one (1) year prior to the application date.</li> <li>▪ Professional license from FL issued at least one (1) year prior to the application date.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Can't verify document is for parent/ legal guardian</li> <li>▪ Documentation not legible</li> </ul>
